ORDER:

In the reference 1st read above, the Government have issued orders framing Policy & Implementation Framework and Comprehensive Guidelines for professional guidance for Civil Services Examination to SC/ST/BC/EBC/KAPU/MINORITIES/BRAHMIN meritorious students in State of Andhra Pradesh through Empanelled Private Coaching Institutes.

2. In the reference 2nd read above, the Director of Social Welfare, AP has submitted a proposal stating that in the meeting of Screening Cum Selection Committee, held on 09-10-2018, under the Chairmanship of Principal Secretary to Government, SW&TW the guidelines framed under the scheme were discussed in detail and certain amendments are proposed to facilitate better management of the scheme and to provide access to students for coaching in reputed institutions.

3. Government, after careful examination of the matter, hereby issue the following amendment to the G.O. in the reference 1st read above, for facilitating better management of the scheme and to provide access to students for coaching in reputed institutions.
