ORDER:

In the G.O. first read above, orders were issued according permission to implement the scheme of providing access to quality education to meritorious poor students belonging to the SC/ST/BC/MW communities who have secured more than 400 marks in the SSC examination in reputed colleges in the private sector at the Intermediate level, to enable them to compete in competitive examinations such as IIT-JEE/AIEEE/EAMCET, to secure seats in premier medical and engineering institutions. Under the scheme reputed private colleges have been identified and students selected from all the 22 Rural Districts through a District Selection Committee. Selected students are then sent to the reputed colleges as opted by students. The total fee payable is Rs. 38,000 per student, of which Rs. 35,000 is towards tuition fee and Rs. 3000 is towards pocket expenses of the student.

2 The scheme was started by the Rural Development department in the Academic year 2008-09. Of the 8000 students admitted, 7477 students who remained on roll at the end of the second academic year were funded from out of SERP funds. The Rural Development Department has requested the relevant welfare departments to fund the scheme from the year 2009-10 onwards. The Rural Development Department continues to conduct the selection process and send students to the reputed colleges. As the academic year 2010-11 was fast approaching, the Rural Development department has selected 5500 students for the financial year 2010-11 based on the recommendations of the Group of Ministers, Vide reference 3rd Cited and commenced the admission process in private reputed colleges to enable students to join the institutions in time.

3. The issue was examined in detail by the Group of Ministers constituted for the purpose vide reference cited above on May 13, 2010. Government after detailed examination of the proposal hereby issue the following orders accordingly:

- (i) From the Academic year 2010-11 admissions shall be provided each year for 5500 meritorious rural students who have secured 400 marks and above at the SSC examination, from the SC/ST/BC & MW communities, in reputed junior colleges in the private sector, with a view to enable them to compete in competitive examinations such as IIT, AIEEE, EAMCET, etc., to secure admissions in premier engineering and medical colleges.
- (ii) Students eligible under this scheme shall have secured a minimum of 400 Marks in SSC examination and will be selected strictly in order of merit by a District Selection Committee at the District level.
- (iii) The maximum admissible fee under the scheme is Rs 35,000 per annum per student towards, fee, Books, Material, Mess and other maintenance charges. The fees under this scheme shall be fixed by the District Collector keeping in view the facilities and prevailing market prices for students studying at the college. The fees for colleges may vary within a district or among districts based on their location.

In addition to the tuition fee students shall be eligible for an amount of Rs.3000/- towards pocket allowance and maintenance charges.

- (iv) The Department wise allocation of 5500 seats is as follows:

- (v) The target of 5500 seats, as per the department wise ratio shall be distributed among all the 22 Rural districts in the state based on the rural population (2001 census). The district wise targets for the departments is appended in annexure IV (a) & IV (b). Under no circumstances shall the specified targets be exceeded.
- (vi) The Tribal Welfare department shall distribute the scheme among the districts based on the district wise tribal population in the categories of scheduled areas 40% PTGs 10% & plain areas 15%.
- (vii) The community wise allocations of seats done by various welfare departments shall be as follows:

- (vii) (a) Out of the seats allocated to Minority Welfare, 80% will be allocated to Muslim & 20% to Christian, Buddhism & Sikh.
- (viii) 60% of the total allocation shall be reserved for girls and 40% for Boys.
- (ix) At least 3% against each quota may be reserved for the Handicapped.
- (x) The mode of selection of meritorious students from various institutions shall be as follows:

1.	Welfare of hostels, Ashram schools and KGBVs	50%
2.	Students of Govt/Municipal/ZillaParishad/Aided High Schools and whose parental annual income is below Rs. One lakh	25%
3.	Students of Govt. / Welfare Residential Schools and Jawahar Navodaya Vidyalayas	20%
4.	Students from Best Available Schools of SW & TW Depts.(with respect to SC & ST students) Note: Where best available school scheme is not available the candidates from any of the above categories may be admitted against the 5% quota.	5%

- (xi) In respect of ST students, the allocation under category 2 is revised to 5% since most of the tribal students are in hostels / Ashram Schools :

- (xii) **District Selection Committee:** The District selection Committee shall be constituted under the chairmanship of the District Collector and shall carryout the administration of the selection process of students and allotment of students to the various reputed colleges as opted by the students. The functions of the committee shall include:

- a) Issue notifications and calling for applications for the selection of students under the scheme.
- b) Shortlist reputed junior colleges for the purpose of the scheme to impart Intermediate & EAMCET coaching.
- c) Monitor the progress and conduct of the reputed junior colleges to which students have been assigned.
- d) Conduct the overall selection process based on the merit in a transparent manner.
- e) Issued allotment orders to the student based on the options exercised of the students and the availability of seats.
- f) Any other issue that will enable the successful selection & counseling process.

- (xiii) **Composition of the District Selection Committee:**

(xiv) Short listing Of Reputed Junior Colleges:

The District Selection Committee shall shortlist the reputed junior colleges based on the following criteria which shall be scrupulously and rigorously assessed with view to shortlist the best available colleges with the excellent track record of imparting education and successful selection a large number of students in the competitive exams of professional course some of the criteria shall include:

- a) Good sufficient residential accommodation with all basic amenities.
- b) The college building should be structurally sound and fire safety norms must be followed.
- c) Adequate infrastructural facilities for classrooms, dormitory, hostels, indoor & outdoor activities etc.,
- d) Consistent academic track record with more than 90% passes with at least 50%, securing first class and distinctions over a period of last years.
- e) Consistent high Success rate in admission tests like IIT/JEE/AIEEE/EAMCET.
- f) Experienced faculty and well equipped lab and library.
- g) The CVs of the faculty shall be examined by the committee.
- h) The colleges identified need not be within the same district
- i) Further, continuation of college under this scheme shall also depend on the results that such students secure and the feedback from such students.

(xv) Selection & Counseling of Candidates:

- a) The selection and counseling of the candidate shall be done by the district selection committee.
- b) In respect of the scheduled areas in the 8 Tribal Districts of Srikakulam. Vizianagaram, Visakapatnam, East Godavari, West Godavari, Warangal, Khammam and Adilabad the selection and allotment of the candidates shall be made by the Project Officer, ITDA.
- c) In respect of allocation of seats for PTGs, the PDs and the Tribal Welfare Department Officers were directed by the Tribal Welfare Department to cover the PTGs in the stream of "Scheduled areas" first and after that, allot them to PTGs.
- d) The applications of the candidates shall be scrutinized with reference to the conditions given in the guidelines.
- e) All the candidates shall be called upon to attend in person, counseling sessions on the stipulated date with necessary documents and photographs.
- f) The dates of the counseling along with the details of the program shall be given wide publicity in the print and electronic media.
- g) The list of identified colleges with all relevant details shall be displayed at the counseling centers.
- h) The candidates can choose to be admitted in any of the identified colleges across the state.
- i) The district level committee shall provide an option form to the candidates/parents for exercising the choice of the college and location.

- j) Against each college, the details of their branches, medium of instruction, courses offered, intake capacity, hostel facility and the academic track record for the last three years shall be furnished by the college management.
 - k) A booklet containing the above mentioned details of the short listed colleges shall be provided to the candidates / parents at the time of counseling.
 - l) The managements of the identified colleges shall make a presentation, explaining the salient features of their colleges at the time of counseling of the selected candidates.
- (xvi) **Choice of College by the Student:**
- a) The choice of the candidate in respect of college and location shall be obtained from the candidates and their parents in the prescribed option form (Annexure II).
 - b) Allotment of candidates to the reputed junior colleges shall be made subject to availability.
 - c) No changes will be permitted after a student is allotted to a college based on his option.
- (xvii) **Registration of Colleges under the Scheme:**
- a) All colleges selected by the District Selection Committee in accordance with the candidates detailed in (xiii), shall register on the e-Pass website for preferring the PMS claims under the scheme.
 - b) Colleges shall furnish their bank account, branch with code.
 - c) Prefer claims of RTF for the students to the concerned welfare department.
- (xviii) **Short Listed Candidates to be Registered on the E-Pass Website.**
- a) The concerned welfare departments shall register the selected candidates on the e-Pass website along with the photograph, income certificate and caste certificate which shall be scanned and uploaded for allowing disbursement of PMS claims under the scheme. The photograph may also be taken through digital camera if available.
 - b) The Welfare officer must take adequate care to enter the correct name and location of the college as this would be basis for sanctioning the RTF and MTF. Entries made once cannot be changed further.
 - c) The concerned college shall acknowledge the website the date on which a student report to the college.
- (xix) **Performance of the Student to be furnished regularly:**
- a) All colleges shall furnish online the details of the academic performance of the students from time to time.
 - b) The details of the attendance of the students shall be furnished monthly (Minimum 75% attendance is needed to be eligible for the scholarship).
- (xx) **Payments under the PMS scheme:**
- a) The District Social Welfare Officer shall forward the fees for the course not exceeding Rs.35,000/- for entries to be made by the PMU after approval by the Commissioner of Social Welfare, in the ePass website at <http://epasswebsite.cgg.gov.in/>.

- b) The payments under the scheme will be remitted online. Colleges due for reimbursement shall prefer a claim.
- c) All payments shall be made only after verification of the students in the college that they are present and studying
- d) The payment for the first year shall be remitted in two installments during the academic year. However, payments for the second year will be subject to the student passing all subjects in the first year.
- e) The Payment of the tuition fee shall be made to the college and the allowance of Rs. 3000/- shall be made to the student account.
- f) Each corporate college identified and student under the scheme shall have a bank account for the amounts payable under the scheme through online remittance.

(xxi) Drawal and payment of the amounts under the scheme:

Since students of a district would be opting to study in different parts of the state, the payment of the PMS bill will be drawn up by the college wise by the Deputy Director of the welfare department concerned district in which the college is located. Since, online registration is being done by the district selection committee allocation of the students is automatically assigned based on the allotment particulars.

- a) The welfare officer concerned must cause to verify that the student allotted to the college has actually joined and undergoing the education.
- b) He shall also update the date of joining on the website.
- c) He shall ensure that colleges update academic performance of each candidates

(xxii) Post Matric Scholarship holder to be treated on par:

All students admitted under the scheme shall be treated on par with the other students. No discrimination, such as segregating such of these students selected under the scheme in a different section from whatsoever shall be indulged into severe action will be initiated on errant colleges, Which shall include stoppage of the scheme to the college.

(xxiii) Colleges to make available Academic performance of the colleges concerned shall make available the academic performance of the students on a monthly basis by posting the academic performance (marks) on the ePass Website.

4. The selections made for 2009-10 are here by ratified and the arrear payments shall be paid by the respective Welfare departments from the Post Matric Scholarship budget of 2010-11, as appended in Annexure-V. Only the payable amounts as specified in annexure-V shall be enabled on the ePass website by CGG. Care must be taken by the concerned welfare departments to deduct any payments already made to the colleges under the scheme and ensure that no excess payments are made under any circumstances.

5. From the year 2010-11, the programme for providing education to meritorious students from weaker sections to study in reputed colleges in private sector is approved for 5500 students at a cost of Rs.42.00 Crores per year (i.e., Rs.21.00 Crores for Fresh students and Rs.21.00 Crores for Renewal students) in (22) Districts (except Hyderabad).

6. The scheme shall be implemented under a twin track approach wherein while admission of the students in reputed private colleges shall continue. In the interregnum, the Government Residential schools shall be strengthened in a manner so as to attain high standards of education on par with the reputed colleges in the private sector and progressively students shall be admitted to such Government Residential Colleges in future over a period of time as may be notified by the Government.

- (a) With a view to promote the twin track approach, 1% of the budget of Post Matric Scholarships of the respective welfare departments shall be allocated to Government Residential Junior Colleges for improvement of infrastructure, teachers, equipping the laboratories and increase the intake of students with an objective to turn these institutions into centers of excellence. These institutions shall over a period of time impart quality education to equip students to compete in competitive examinations on par with reputed colleges in the private sector.
- (b) The expenditure towards providing quality education to students of weaker sections in colleges of repute in the private sector shall be met out of the funds for Post Matric Scholarships of the concerned Welfare Departments.

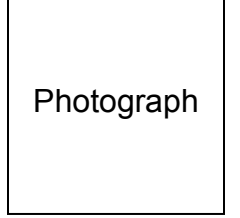
